## Order of Events

- 1300 Arrival of Official Guests
- 1315 Members and guests assemble in the Quarterdeck
- 1330 Immediate Past Commodore John Midolo calls for order for the Official Ceremony
- 1331 Welcome to Country—Marie Taylor, Elder-in-Residence
- 1334 Welcome by Commodore Michael Cook
- 1338 Address by Rear Commodore Troy Dalglish
- 1340 Announcement of Rodney Nott Sheild
- 1345 Commodore declares the Season open. Cannon is fired. Club burgee is broken out by RC Dalglish to officially open the time trial season.
- 1350 Official guests move to the main jetty for new vessel Christening.  
  
Power yacht members adjourn to their vessels immediately after to prepare for the Sail Past.
- 1355 Immediate Past Commodore asks Official Guests to adjourn to VIP vessels on Jetty 1 for the sail past.
- 1430 Commodore Michael Cook salutes the sail past.
- 1455 VIP Boats depart Jetty to watch Time Trial from the river
- 1515 Opening Day time trial—first boat away on Course 401.
- 1630 VIP boats return and Official Guests move to the Quarterdeck for snacks.
- 1700 Competitors return to the Quarterdeck. Food platters available for competitors.
- 1800 Announcement of results and evening a la carte meals.

## **Instructions for Sail Past**

- 1400 Leave mooring area and proceed to rendezvous north of Sampson Spit. Power yachts should form up in line as per diagram, behind the lead boats which will be stationary to the West of Sampson Spit. Communication will be via the Marshall Boat on VHF Channel 69.
- 1410 1st Lead boat to head for Outer Red Spit followed by the other vessels at two boat length intervals, with the lead boats, and then all others following as per the diagram.
- 1420 Boats shall enter Heathcote Channel with the lead boat reaching the Saluting Base at 1430.
- After saluting, vessels are requested to proceed on course for a further 100 metres before leaving formation.
- 1500 Last boat through the sail past.

## **General Note**

Skippers shall salute the Commodore from the after deck with all crew members seated (with the exception of helmsman and crew dressing the deck).

Skippers are requested to dress their vessel for this ceremony and endeavour to fly the Australian Flag.

Any instruction given by the Marshall Boat shall be executed promptly. Time Trial shall start at 1515.

Dress is winter dress - white topped caps.
